# Registration and entry windows

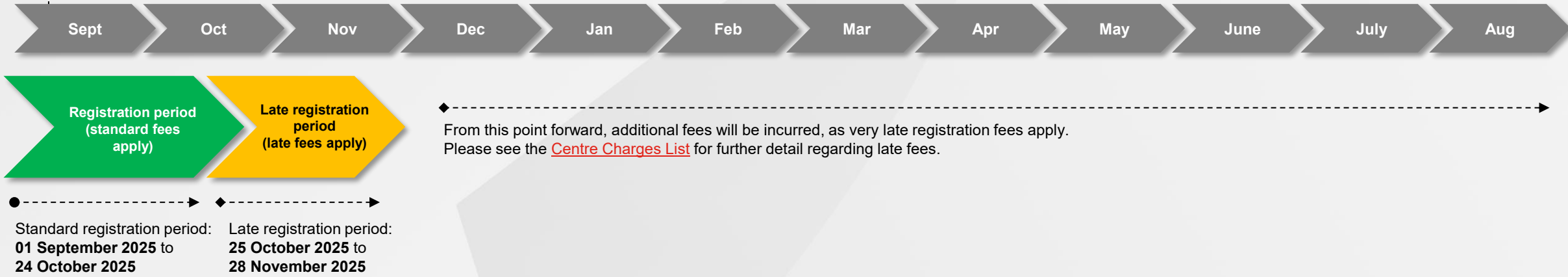
# Registration windows



Centres are encouraged to register learners at the start of the academic year in which delivery begins, and before the standard registration cut-off date to avoid incurring late registration fees. This applies even in cases where the centre does not intend to enter learners onto assessments until the second year of delivery.

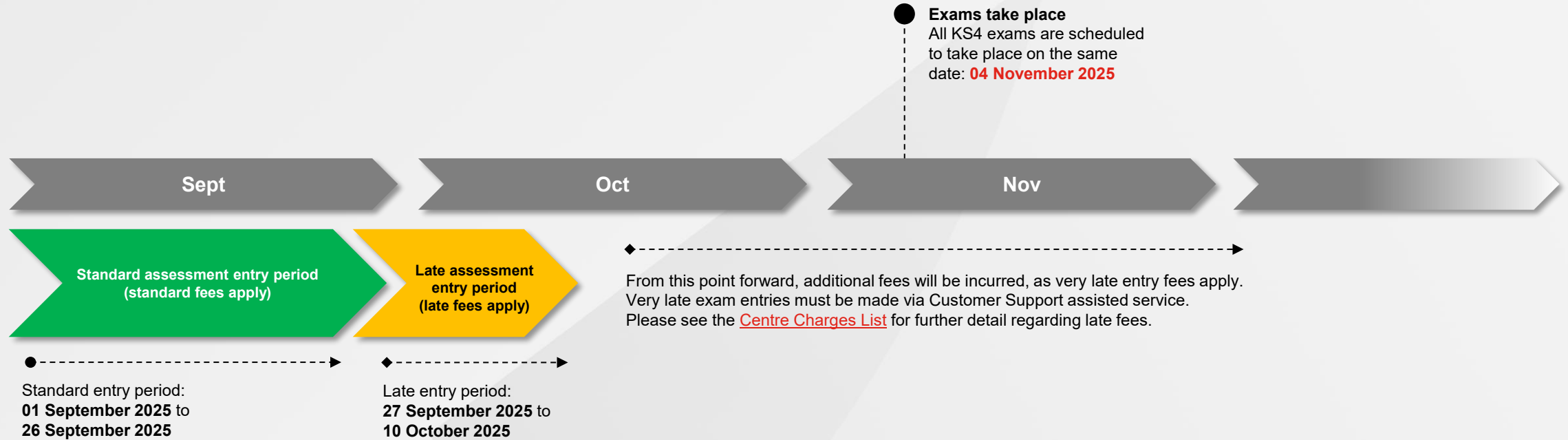
Technical Qualifications will incur late and very late fees for any registrations made outside of the standard registration period per academic session, as outlined below:

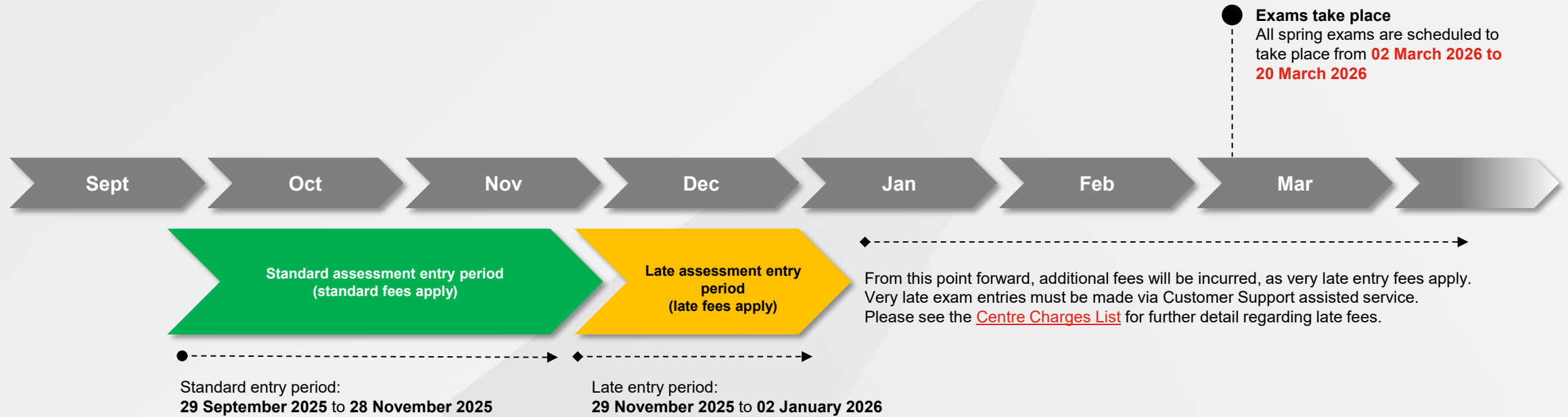

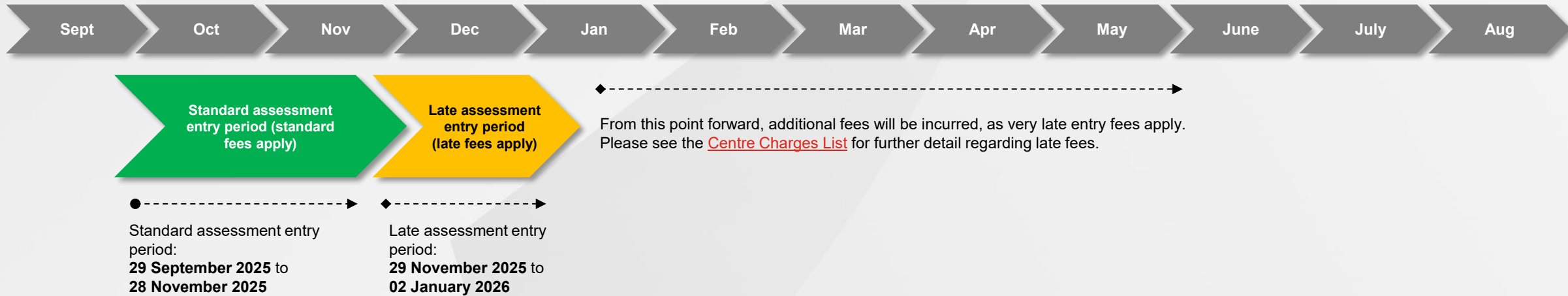

## Synoptic, centre assessed, and employer involvement



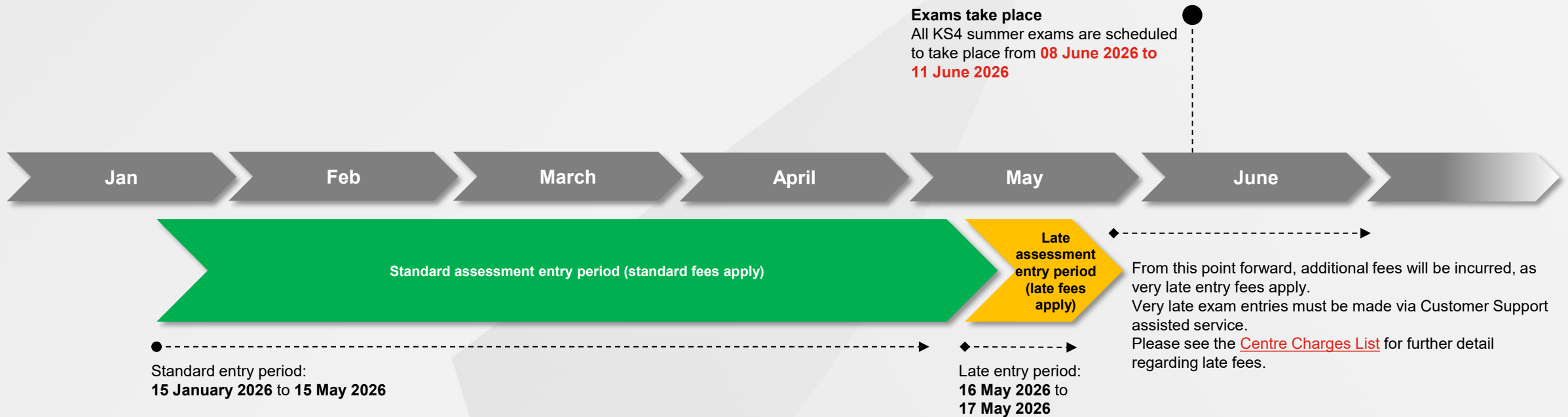
At the start of each academic year, centres must enter learners onto the assessments which they intend to deliver within that academic year.

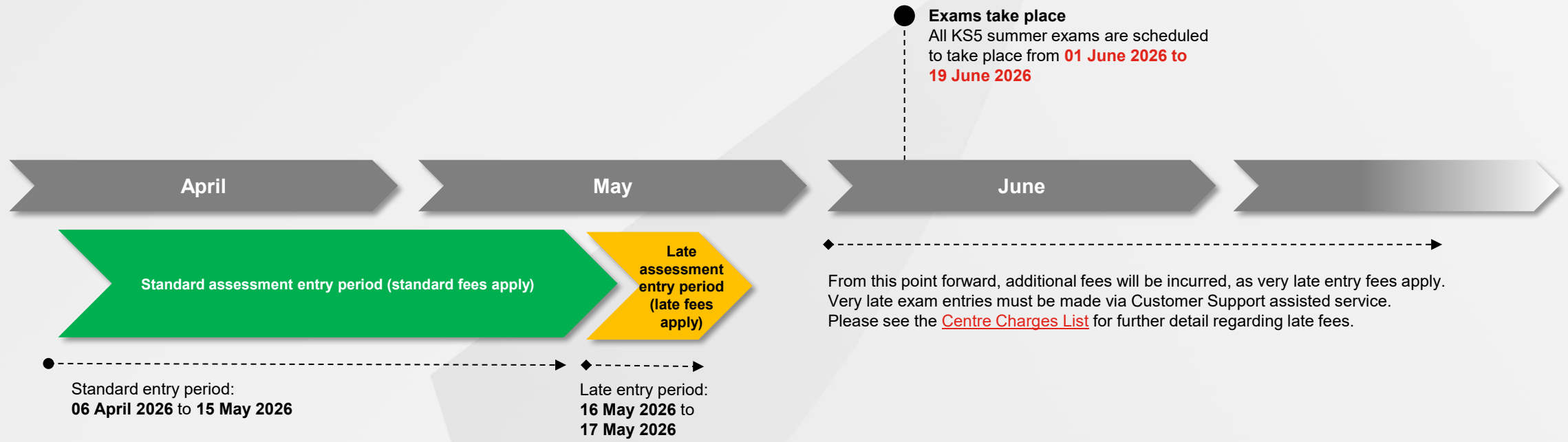

# Synoptic assignments



The finalised version of the synoptic assignments will be published by **03 November 2025**.

**05 January 2026 to 15 May 2026:**

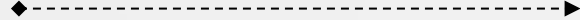
Centres may schedule the synoptic assessments within this period (however, please remember that 15 May is the final date for providing evidence for moderation, so allow time for marking and quality assurance to avoid incurring late submission fees).

Please see specific details of permitted timings of the assessment within each synoptic assignment pack.

Some synoptic assessments are subject to a moderation visit.

**Synoptic Assignment delivery window:**  
Assignments can be delivered to students within this period

**Submission deadline: 15 May**



The deadline for submission of all synoptic assignment marks and evidence is **Friday, 15 May 2026**.

Any late submissions from this point forward are subject to additional administrative fees, as published within the [Centre Charges List](#).

# Centre assessed components

In w / c **20 April 2026**, the Quality team will notify centres of which centre assessed components have been selected as the 'defined sample'. This is the student evidence which must be uploaded to us for sampling.

The grades and evidence for all candidates within the 'defined sample' must be submitted via the Moderation Portal by **Tuesday, 02 June 2026**.

For all other centre-assessed components which are not part of this defined sample (including work experience units and Employer Involvement for Key Stage 5), the deadline submission date is **Friday, 12 June 2026**.

**"Defined sample" submission deadline: 02 June**  
**Remaining centre assessed component and EI submission deadline: 12 June**

Centre assessed components can be taught and assessed at any point throughout the academic year



Any submissions of grades and evidence after these published deadlines are subject to additional administrative fees.
